CHIEF'S REPORT:

The Chief's report was unavailable.

CAPTAINS REPORT:

Captain thanked the career staff, volunteers and EMT for being so accommodating during the renovations/construction which is going well.

Captain reported that Camp Pace at School #28, requested an engine on August 8 from 9am-2pm and any members and volunteers are invited to attend.

Captain reported that Engine 2-2 has completed the annual preventive maintenance.

Captain reported that Buckeye will handle the bills for any repairs on the foam pumper for preventative maintenance.

Captain reported that the air conditioning has needed to be repaired on Engine 2-1 for over five years and preventive maintenance and pump test is needed as well. Captain received a estimate from Absolute of \$1,690.00to fix the air conditioning.

Captain reported that there will be a First Responders Appreciation Day at Millers Ale House on August 5.

Captain thanked Firefighter Mayti for his assistance in getting lumber donated to build a portable ventilation prop that was mounted to the flatbed for the July drill.

Captain stated that he working on with the community center to have a water drill on August 25 from 7:00pm-9:00pm, which they will open up to the Police Department and requested that the Board consider approving the overtime.

Captain reported that the Firefighter recruit is doing well and taking the state test on August 10 and that all of the firefighters have been accommodating.

Captain stated that there will be a Live Burn in October, which will require authorization on overtime for the entire staff.

Comm. Huber inquired about the air conditioning on Engine 2-, which has not been working for a five years and stated it is needed as a refuge for the firefighters. A motion was recommended to fix the air conditioning if money was available. Board Accountant Bucsanszky and Comm. Santorelli indicated that we are over budget for that line item. Comm. Santorelli suggested researching other companies for the repairs and will be tabled until the September meeting.

Comm. Santorelli stated that we are close to going over budget in the overtime line item and will get back to Captain DeLeo regarding overtime.

MOTION to accept the Captain's Report made by Comm. Santorelli, seconded by Comm. Huber. All in favor 4-0.

FIRE OFFICIALS REPORT:

The Fire Officials Report was unavailable and tabled until the September Meeting.

Comm. Nardiello reported that he met with Safety Committee and there were no new matters.

TAXPAYERS COMMENTS:

Steve Weber from the Port Reading First Aid Squad stated that it would be a slap in the face if "First Aid Squad" was not put on the building and requested that the Board reconsider so that the First Aid Squad is recognized.

Comm. Nardiello stated that there is room for conversation regarding this issue and Comm. Galvach had requested that this matter be tabled until the September meeting.

Comm. Santorelli stated that they do not want to slight the First Aid Squad and that "Port Reading Fire District Number 2" would encompass all. Comm. Nardiello requested that Mr. Weber come back to the next meeting with his request.

MOTION to enter Executive Session at 7:55pm to discuss insurance, LOSAP and contractor work in building, made by Comm. Zullo, seconded by Comm. Santorelli.

Captain DeLeo stated that he has sent emails regarding the changes made with the contractor, which include the sidewalk, changing the pitch for draining, no sprinkler covers and using stone and moving the old hose for decoration.
